The Greenham NEVER EVER Beef Program was established in 2012 to source, certify and promote premium quality natural grass-fed beef from producers across Southern Australia.

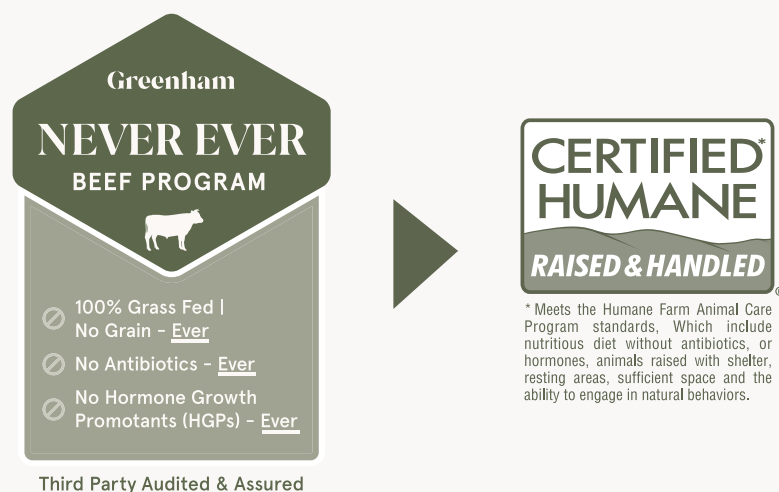
From its inception, the Greenham NEVER EVER Beef Program has proudly sourced beef that is:

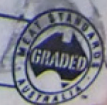

3. WHAT ARE THE REQUIREMENTS FOR NEVER EVER?

LIVESTOCK

1. All livestock must have records showing complete lifetime traceability.
2. Livestock must be individually identified:
 - NLIS tag: prior to leaving and purchased arrivals on to the farm
 - NLIS/management tag and red "treated" tag: any antibiotic treated livestock.
3. Livestock must be fed a wholesome 100% grass-fed and 100% vegetarian diet (exception of milk or milk replacer prior to weaning) for their entire life.
4. Livestock must have free access to clean nutritious feed of sufficient quantity and quality to sustainably maintain an Australian Body Condition Score of 2.5 or higher.
5. Supplementary feeding may be used to compliment grazing, as support during adverse seasonal conditions or at time of weaning.
6. Livestock must have continuous access to clean drinking water.
7. Livestock must never be fed a diet that includes grain or grain byproducts.
8. Livestock must never be confined to a feedlot or intensive yard finishing system.
9. Livestock must never have access to genetically modified crops.
10. Livestock must never be fed any finishing diets that include therapeutic antibiotics or steroids.
11. Livestock must never be administered hormone growth promotants or ionophores.
12. No animal may be denied treatment when sick or injured. An animal identified to require antibiotic treatment must be treated promptly. The treated animal must be excluded from the Program.
13. Prohibited marking of livestock include: face branding, ear splitting, tail docking, wattling.
14. The use of genetically modified and/or cloned animals and their offspring is prohibited.
15. Castration must only be undertaken on healthy animals. Pain relief treatment must be used for all castration procedures when the animal is older than 7 days.
16. Disbudding and dehorning must only be undertaken when necessary and on healthy animals. Pain relief treatment must be used for all disbudding and dehorning procedures.
17. Calves must not be weaned from their mothers before an average of six months of age. Exceptions may be made if the welfare of the mother and/or calf is compromised.

"The environment in which livestock are raised must be conducive to good health. The Manager must have an Animal Health Plan that is in accordance with good veterinary and husbandry practices and promotes high animal welfare practices."

4. MANAGEMENT

1. A Health Plan must be documented including details regarding annual health treatment, biosecurity plan, non-ambulatory procedures and euthanasia procedure.
2. A Farm Plan must be documented including all farm husbandry records, an emergency plan for natural disasters and the animal welfare standards of Greenham NEVER EVER, Certified Humane and Animal Health Australia.
3. If working stock dogs are used they must be properly trained and kept under control at all times.
4. Electric prodders (hot shots) are only to be used on livestock if there is impending harm to the operator or animal (and must not be common practice).
5. The Property Identification Code (PIC) of the farm must be accredited with Livestock Production Assurance (LPA) and Meat Standards Australia (MSA).
6. All personnel handling livestock must do so in a positive and compassionate manner and must be competent in procedures that have potential to cause suffering.

"The Manager must have appropriate training or experience to ensure management systems promote best practice. Management procedures should be documented to ensure best welfare practices are understood and followed by all livestock personnel."

5. ENVIRONMENT

1. Livestock must have protection from predation and pests where possible.
2. Livestock must be provided with adequate space in pastures to perform normal patterns of behaviour.

6. ANIMAL TREATMENTS

Disclaimer: The choice of pain relief depends on the type of procedure being performed and the circumstances under which it is being performed. Please speak to your veterinarian to get specific advice relevant to your needs. If in doubt, speak to your veterinarian prior to administering any treatment.

Pain Relief options for beef animals come in two broad categories – systemic or topical. Systemic drugs are either injected or given orally and affect the entire body. Topical pain relief options are applied directly to the painful area and act to desensitize the pain response at that site.

The pain relief drugs currently available in Australia are injectable anti-inflammatories (e.g. Metacam, Tolfidine or Flunixin), oral anti-inflammatories (e.g. Buccalgesic) or topical local anesthetics (e.g. Tri-Solfen).

Recommended treatment according to procedure:

CASTRATION

Banding: Injectable or oral anti-inflammatory.

Surgical: Injectable or oral anti-inflammatory and/or topical local anesthetic.

DISBUDDING / DEHORNING

Injectable or oral anti-inflammatory and/or topical local anesthetic.

ANTIBIOTIC TREATMENTS

Where any of the listed prohibited antibiotics are administered to animals via feed, water or injection, a red 'treated' ear tag must be applied.

Treated cattle identified with a red 'treated' tag may remain, and be consigned for processing, with the herd.
